- For a payment by bank transfer or cheque, send us the form via our website. At the same time, your payment must be ordered.
 - For a payment by credit card, print the completed form, add your credit card details by hand and send us the form by fax at +377 99 99 88 25.
- Upon receipt of your registration, we will send you an invoice with a confirmation. Should you need an invoice prior to initiating payment, please contact the organiser.

Exhibition Exhibitors must comply with the exhibitor's manual which they will receive upon registration.

The organiser reserves the right to change the position of the stand in the exhibition hall, in which case the exhibitor will be notified before the start of the event.

While every effort will be made to accommodate the wishes of prospective exhibitors, VB International reserves the right to decline registration for the exhibition if the activities of the registrant would not justify its inclusion, and in such circumstances any amount paid to the organiser for the registration will be reimbursed in full.

Conference passes Conference passes are non-transferable during the event.

Visitor passes Free visitor passes must be ordered before the start of the event. Otherwise registration on site will be charged 90 euros including VAT. The organiser reserves the right to decline the registration for a free visitor pass without explanation.

System for pre-arranging meetings The system is available for free to all participants except to those who ordered a free visitor pass.

Hotel booking Requests for hotel booking will be subject to availability. Demand for hotel booking will be high, therefore the earlier you book your room, the better to secure your choice of reservation.

Cancellations Any cancellation for stand / sponsorship must be submitted in writing before 01/02/2007 and will be subject to a 40% service charge. No refund will be made on cancellations received after 01/02/2007.

Cancellations for conference pass / upgraded visitor pass must be submitted in writing before 15/02/2007. No refund will be made on cancellations received after 15/02/2007.

Cancellations on hotel booking must be submitted in writing before 01/03/2007. No refund will be made on cancellations received after 01/03/2007, due to the very special rates negotiated with the hotels implying this special condition.
